#### From the Chair

### **YOUR FAQs**

#### Are we locked in to LMA?

We are still in the Transition Phase of the project. In this phase Theodore Water Pty Ltd is conducting Due Diligence on the recent offer from the Government.

Once the Due Diligence is complete there will be a public consultation where all stakeholders will get an opportunity to express their levels of support for the transition to local management arrangements under Theodore Water Pty Ltd.

Support by local customers remains a requirement for transition.

#### Is this for all SunWater Customers?

No, this project only effects those non-bulk water customers on the Theodore Irrigation Scheme.

#### When does the offer expire?

The deadline for community support and transition of the assets to Theodore Water Pty Ltd is 01 July 2018

## How will Theodore Water be governed and how will customers be involved in decisions?

Theodore Water will be a Company limited by Shares. After transition the Shareholders in the company will be the customers. A revised constitution and Board will be put in place. Typically the Shareholders will have the ability to approve the Business Plan and then delegate to the Board for its implementation.

The rights of all shareholders will be protected by key voting activities in the constitution and a committee to allow issues to be raised with the Board.

#### 5 top Apps for water users

For this newsletter we have searched the internet high and low and pulled together 5 Apps for Water Users.



CliMate is a suite of climate analysis tools delivered on the Web, iPhone, iPad and iPod Touch devices. The App allows you to interrogate climate records (over the last 60 yrs) to ask a number of questions relating to rainfall, temperature, radiation, as well as derived variables such as heat sums, soil water and soil nitrate.



Yr is a service from the Norwegian Meteorological Institute and NRK that many Australians have turned to for its reliability and accuracy in predicting weather in Australia



The Willy Weather app features BoM radar and satellite information ensuring accurate wind, tide, swell and UV forecasts, moon phases and sunrise/ sunset. 7 day forecasts, Radar, and Satellite are a few features.



The Yield Free Grower's App delivers public weather data from a grower's perspective.

It provides all the growing conditions you need, and nothing you don't, from water balance, evapotranspiration (ETo) and rainfall to humidity and wind activity.



Weed ID: The Ute Guide application is designed to assist growers in the identification of the most common weeds found in paddocks throughout Australia.
